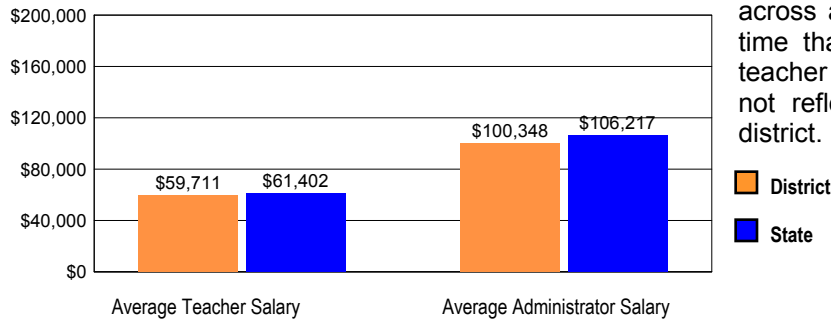

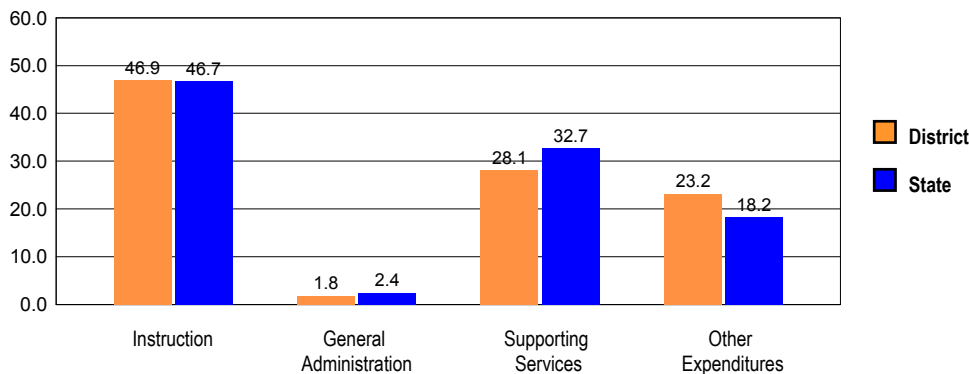
SCHOOL DISTRICT FINANCES

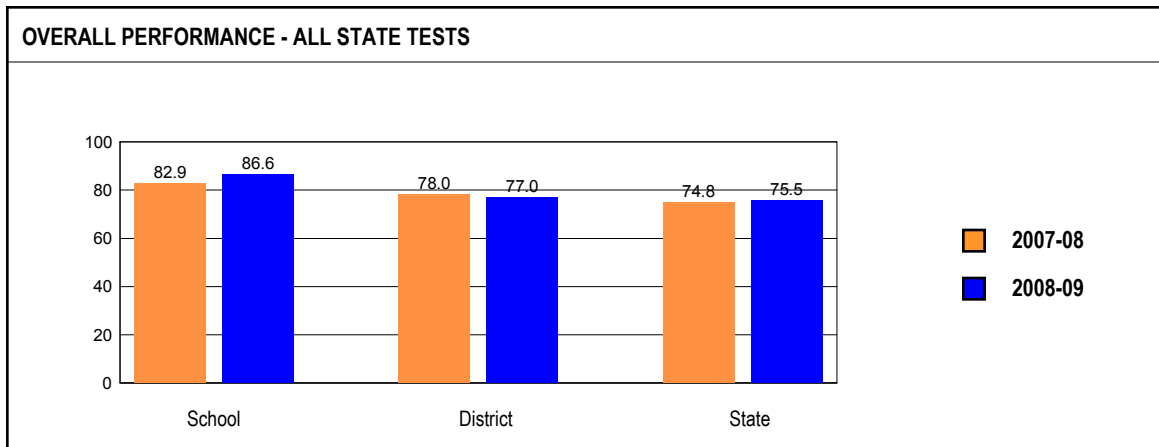

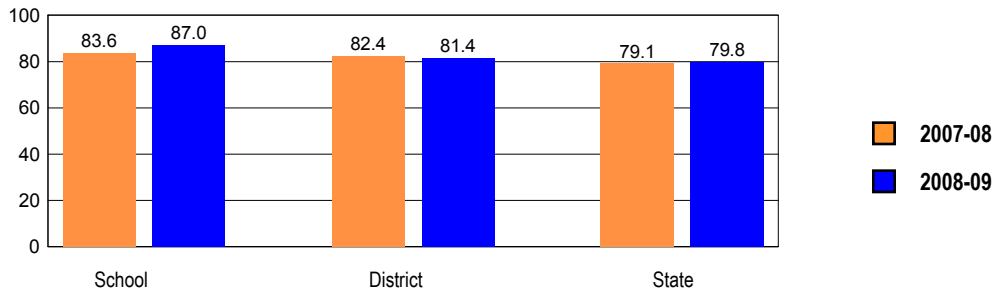
OVERALL STUDENT PERFORMANCE

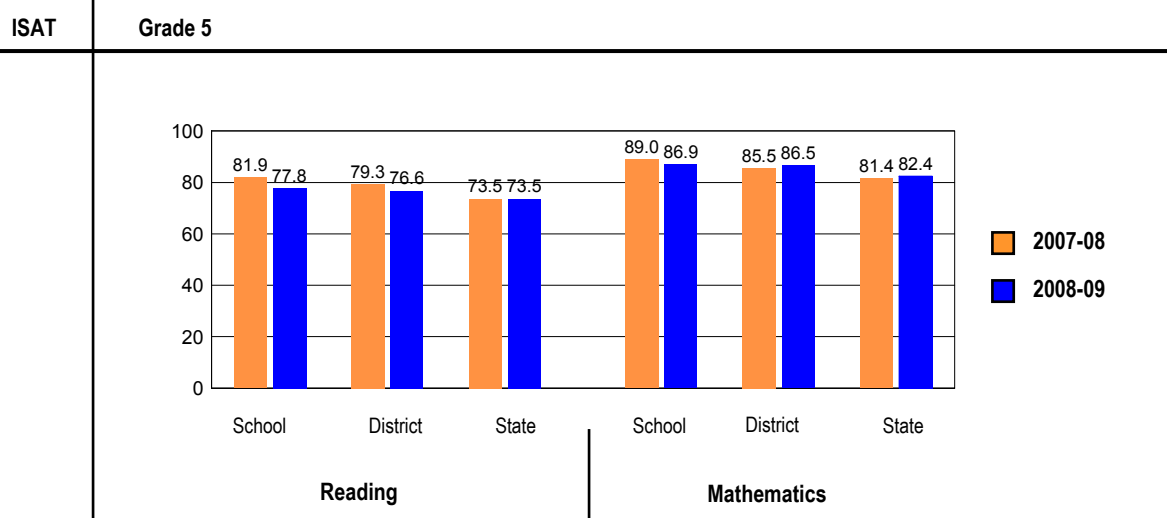
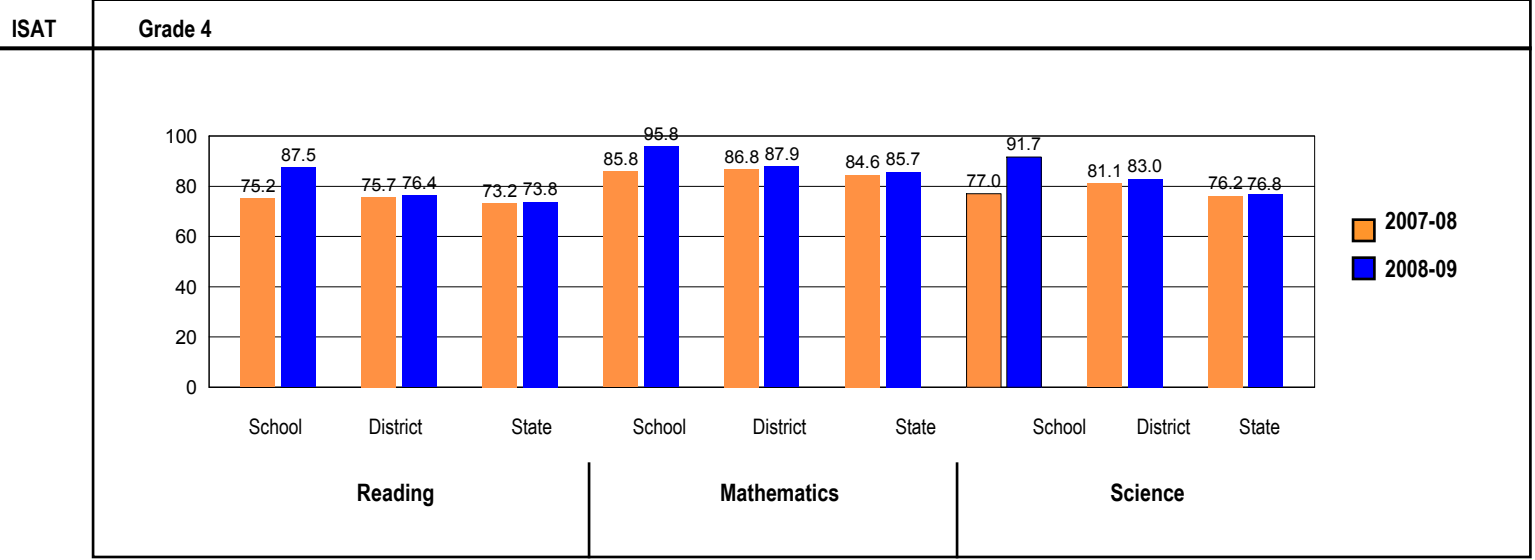
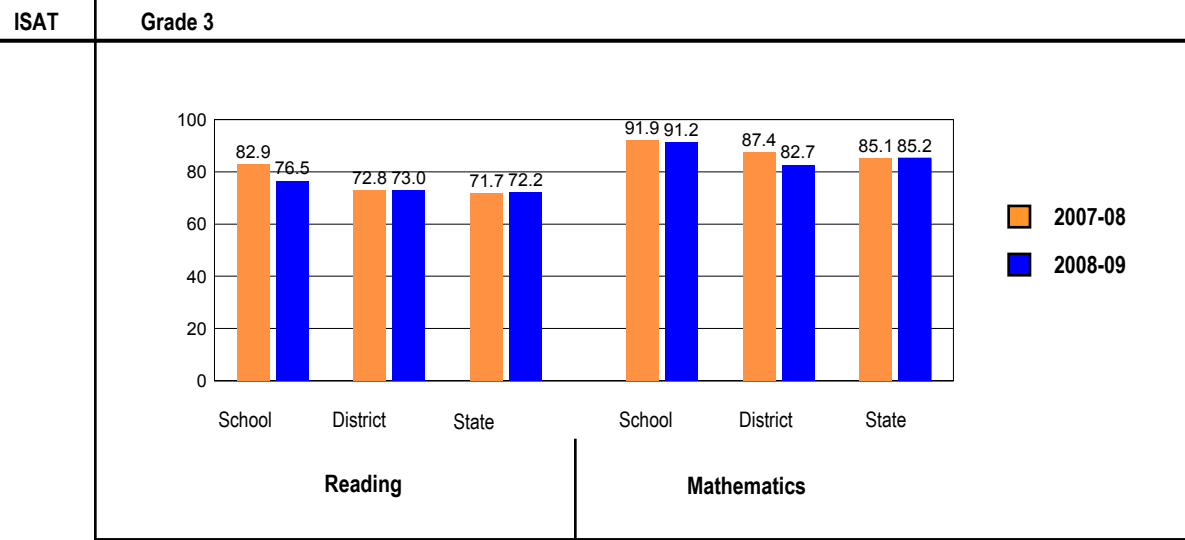


OVERALL ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT) PERFORMANCE

PERFORMANCE ON STATE ASSESSMENTS

Federal law requires that student achievement results for reading, mathematics, and science for schools providing Title I services be reported to the general public.

The Illinois Standards Achievement Test (ISAT) is administered to students in grades 3 through 8. The Prairie State Achievement Examination (PSAE) is administered to students in grade 11. The Illinois Alternate Assessment (IAA) is administered to students with disabilities whose Individualized Education Programs (IEPs) indicate that participation in the ISAT or PSAE would not be appropriate.

Students with disabilities have an IEP (No Child Left Behind Act). An IEP is a written plan for a child with a disability who is eligible to receive special education services under the Individuals with Disabilities Education Act.

Reading and Mathematics are tested in grades 3 through 8 and 11. Science is tested in grades 4, 7, and 11.

In order to protect students' identities, test data for groups of fewer than ten students are not reported.

ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT)

The following tables show the percentages of student scores in each of four performance levels. These levels were established with the help of Illinois educators who teach the grade levels and learning areas tested. Due to rounding, the sum of the percentages in the four performance levels may not always equal 100.

- Level 1 -- Academic Warning - Student work demonstrates limited knowledge and skills in the subject. Because of major gaps in learning, students apply knowledge and skills ineffectively.
- Level 2 -- Below Standards - Student work demonstrates basic knowledge and skills in the subject. However, because of gaps in learning, students apply knowledge and skills in limited ways.
- Level 3 -- Meets Standards - Student work demonstrates proficient knowledge and skills in the subject. Students effectively apply knowledge and skills to solve problems.
- Level 4 -- Exceeds Standards - Student work demonstrates advanced knowledge and skills in the subject. Students creatively apply knowledge and skills to solve problems and evaluate the results.

PLANNED IMPROVEMENT FOR THE SCHOOL AND DISTRICT

The Illinois Standard Achievement Test (ISAT) was administered to Meehan Elementary students in March, 2009. Third, fourth, and fifth grades were tested in reading and math. In addition, fourth grade students were tested on their knowledge of science and third and fifth grade students were administered the writing portion of the test.

The state criterion of 70% was met in all areas except in the subgroup of Students with Disabilities. All third, fourth and fifth grade Meehan students scored higher than the average for schools in the district and state in reading and math. The third grade overall reading scores decreased from 82.9% in 2008 to 76.5% in 2009. Fourth grade overall reading scores increased from 75.2% in 2008 to 87.5% in 2009. Fifth grade student reading scores decreased from 81.9% in 2008 to 77.8% in 2009. Third grade overall math scores decreased from 91.9% in 2008 to 91.2% in 2009. Fourth grade overall math scores increased from 85.8% in 2008 to 95.8% in 2009. Fifth grade overall math scores decreased from 89% in 2008 to 86.9% in 2009. Fourth grade science scores increased significantly from 77% in 2008 to 91.7% in 2009. Writing scores for third grade were 73.4% and fifth grade scores increased to 77.2%.

School demographic data identified two subgroups at Meehan: Students with Disabilities and Economically Disadvantaged. The subgroup of Students with Disabilities did not make Adequate Yearly Progress at 43.6% (57.5% including safe harbor) of students meeting or exceeding. The subgroup of Economically Disadvantaged students made AYP with 72.9% of students meeting or exceeding. This is the first time Meehan Elementary School did not make AYP. School wide data teams, grade level teams, and individual teachers spend time identifying students, areas of weakness, and academic skills to focus on for the 2009-2010 school year.

The School Improvement Plan for 2009-2010 reflects continued high standards for all students in reading, math, and science. Highly qualified teachers use and share best practice strategies to encourage the love of learning and to achieve the high academic standards we have come to expect. A district emphasis on Response to Intervention (RTI) provides data from a nationally normed test (AIMS web) to identify students who need additional interventions. Grade level core curriculum is being evaluated and teams meet to discuss individual student needs.

Professional development opportunities continue to be offered at the building level through Collaborative Learning Time (CLT) which is built into the monthly calendar. District professional developers will assist in the training as well as Meehan staff who volunteers to attend additional RTI training. Two professional book clubs have been established pertaining to RTI.

A ninety minute reading block has been scheduled for all classrooms. Whole group instruction and differentiated guided reading groups are held during this time. Resource and supplemental reading support is provided during this time period as well as additional interventions throughout the day. This change is one intentional strategy for addressing student needs, especially those who fall into the category of Students with Disabilities.

Continued school improvement activities include: an active and engaged Parent/Teacher Organization, student council, family reading nights, "One School One Book" literacy events, involvement of "Partners in Education" with Zion Lutheran Church, classroom buddies, computer programs aligned with standards, Internet Safety curriculum, PBIS, and grade level collaboration. The Meehan staff looks forward to a year of focusing on the academic growth of all students, with an emphasis on the Students with Disabilities subgroup.
