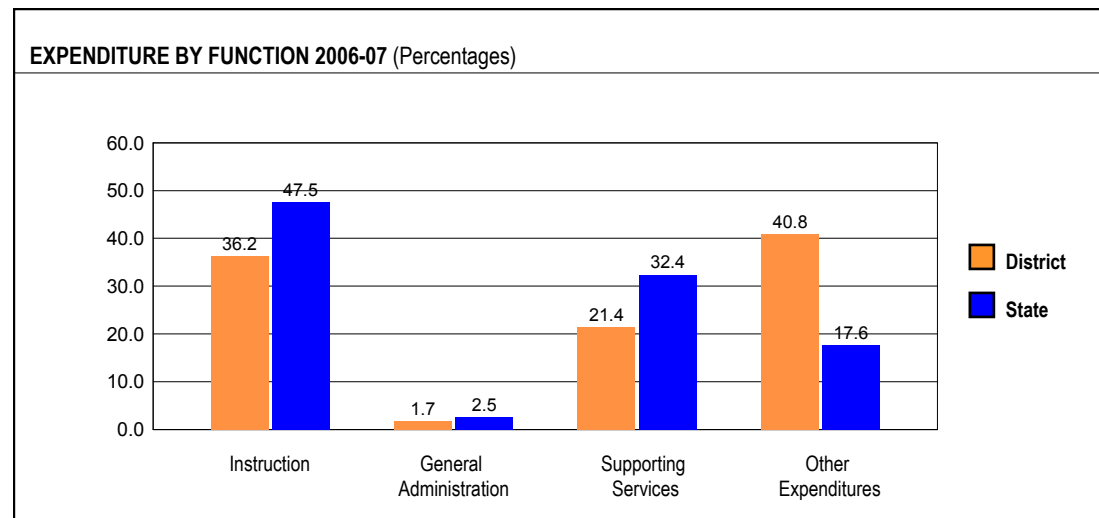

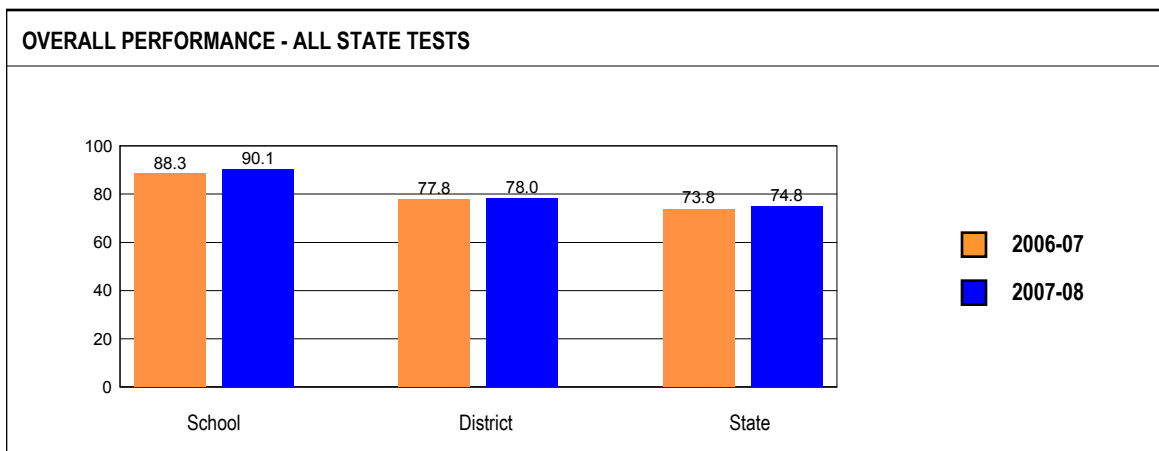

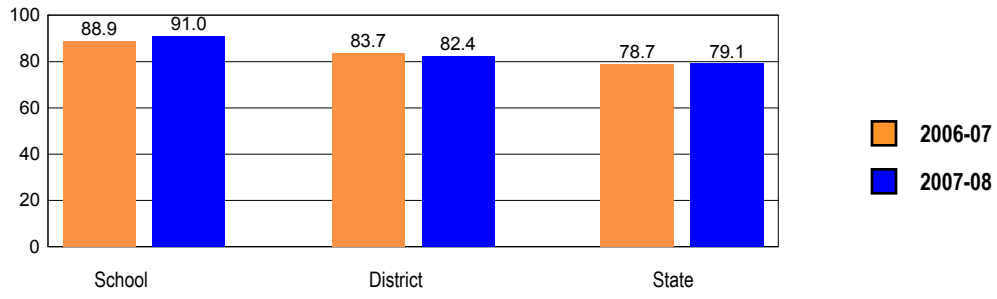
OVERALL STUDENT PERFORMANCE

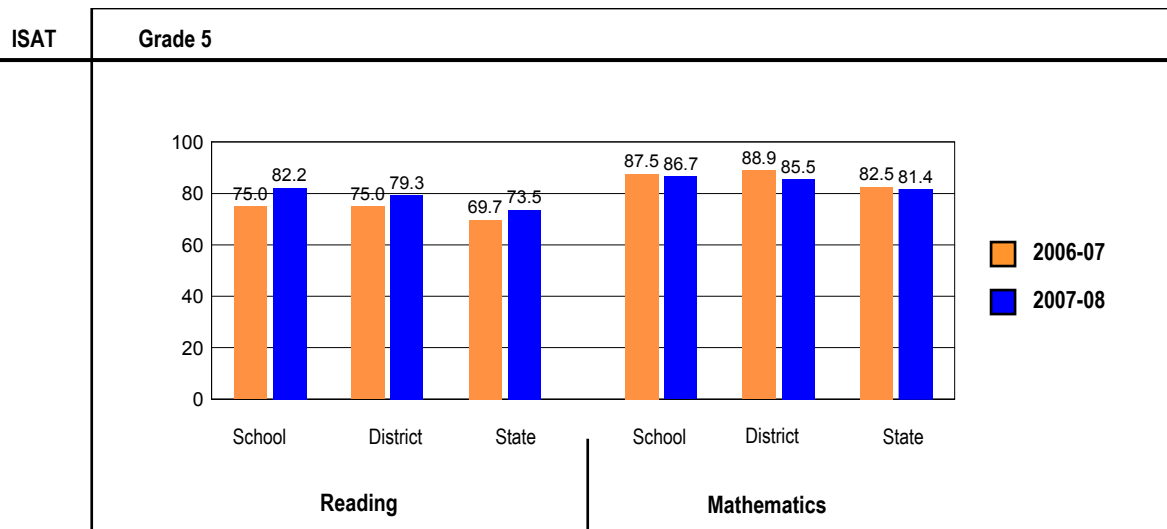
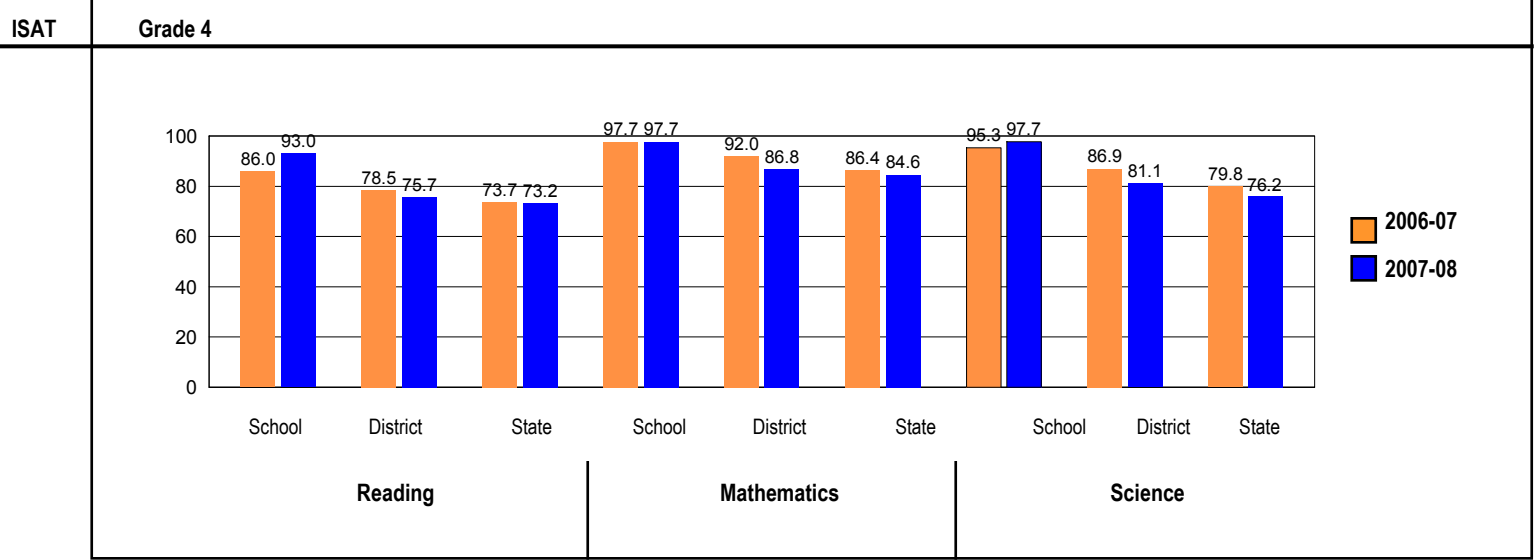
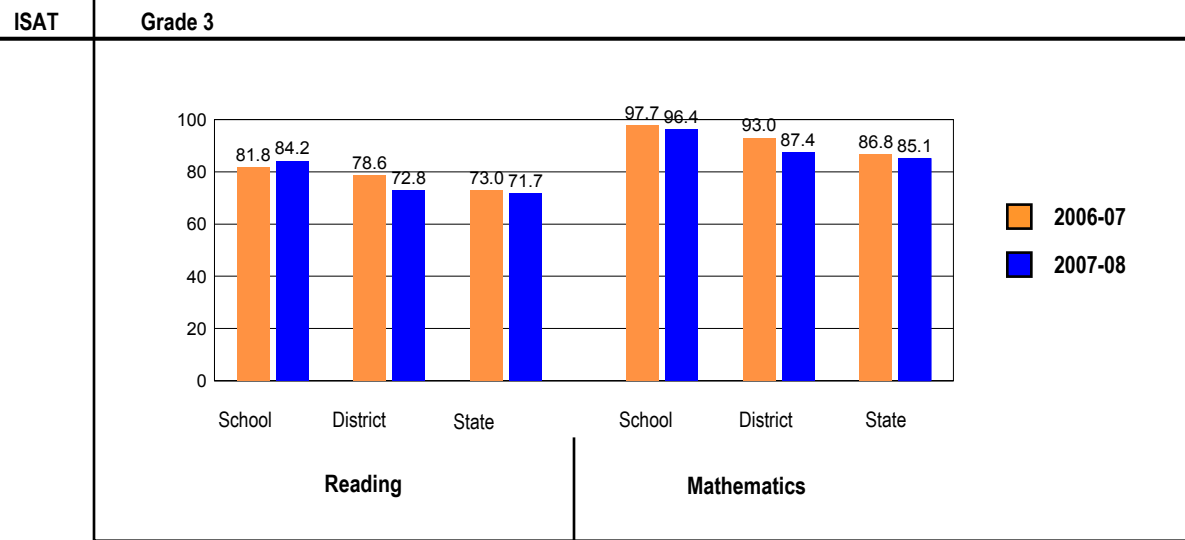


OVERALL ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT) PERFORMANCE

PERFORMANCE ON STATE ASSESSMENTS

Federal law requires that student achievement results for reading, mathematics, and science for schools providing Title I services be reported to the general public.

The Illinois Standards Achievement Test (ISAT) is administered to students in grades 3 through 8. The Prairie State Achievement Examination (PSAE) is administered to students in grade 11. The Illinois Alternate Assessment (IAA) is administered to students with disabilities whose Individualized Education Programs (IEPs) indicate that participation in the ISAT or PSAE would not be appropriate.

Students with disabilities have an IEP (No Child Left Behind Act). An IEP is a written plan for a child with a disability who is eligible to receive special education services under the Individuals with Disabilities Education Act.

Reading and Mathematics are tested in grades 3 through 8 and 11. Science is tested in grades 4, 7, and 11.

In order to protect students' identities, test data for groups of fewer than ten students are not reported.

ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT)

The following tables show the percentages of student scores in each of four performance levels. These levels were established with the help of Illinois educators who teach the grade levels and learning areas tested. Due to rounding, the sum of the percentages in the four performance levels may not always equal 100.

- Level 1 -- Academic Warning - Student work demonstrates limited knowledge and skills in the subject. Because of major gaps in learning, students apply knowledge and skills ineffectively.
- Level 2 -- Below Standards - Student work demonstrates basic knowledge and skills in the subject. However, because of gaps in learning, students apply knowledge and skills in limited ways.
- Level 3 -- Meets Standards - Student work demonstrates proficient knowledge and skills in the subject. Students effectively apply knowledge and skills to solve problems.
- Level 4 -- Exceeds Standards - Student work demonstrates advanced knowledge and skills in the subject. Students creatively apply knowledge and skills to solve problems and evaluate the results.

1. At least 95% tested in reading and mathematics for every student group. If the current year participation rate is less than 95%, this condition may be met if the average of the current and preceding year rates is at least 95%, or if the average of the current and two preceding years is at least 95%. Only actual participation rates are printed. If the participation rate printed is less than 95% and yet this school makes AYP, it means that the 95% condition was met by averaging.
2. At least 62.5% meeting/exceeding standards in reading and mathematics for every group. For any group with less than 62.5% meeting/exceeding standards, a 95% confidence interval was applied. Subgroups may meet this condition through Safe Harbor provisions. ***

The Illinois Standard Achievement Test (ISAT) was administered to Perry School students in March of 2008. Students in grades 3 through 5 were tested in the areas of reading and math. Fourth graders, in addition to reading and math were tested in the area of Science. Fifth graders in addition to being tested in reading and math were tested in writing. During the course of each year, we analyze student performance and develop plans for improvement.

In examining the 2008 ISAT scores, we found that our students scored well in most areas, especially when compared to district and state scores. For example, 84.2% of our third graders met or exceeded standards in reading compared to 72.8% in the district and 71.7% in the state. Likewise in math, 96.4% of our third graders met or exceeded standards compared to 87.4% in the district and 85.1% in the state. In fourth grade, 93% of our students met or exceeded standards in reading compared to 75.7% in the district and 73.2% in the state. In math, 97.7% of our fourth grade students met or exceeded standards in math as compared to 86.8% in the district and 84.6% in the state. In science, 97.7% of the fourth graders met or exceeded standards, compared to 81.1% in the district and 76.2% in the state. At the fifth grade level, 82.2% met or exceeded standards while the district scored 79.3% and the state scored 73.5 % in reading. In math, 86.7% of the fifth grade met or exceeded standards in comparison to 85.5% in the district and 81.4% at the state level. In writing, 36% of the fifth graders met or exceeded standards, compared to 68% in the district and 55% in the state.

Based on the aforementioned writing scores at fifth grade, teachers will focus on increasing writing achievement. The educational team will put an emphasis on expository writing, with beginning skills at the primary level.

In addition to data from ISAT and other measurements of assessment are used to develop plans to improve student learning and performance. These include, but are not limited to:

- Implement components of the district's Balanced Literacy Program with an emphasis on becoming comfortable with the new reading series
- Teachers continue to attend professional development opportunities that focus on research-based strategies in reading, math and writing
- Teachers work across grade levels to scaffold skills that are aligned to state standards
- Teachers attend training regarding the district initiatives of Response to Intervention, PBIS (Positive Behavior Intervention Supports)

Perry staff continue to strive to offer our students strong instructional programming along with a positive environment in which to learn. Programs are offered as additional support to improve reading and math skills. These include C.A.R.E. (Computer Assisted Reading Enrichment); Accelerated Reader; P.R.I.D.E. (Panthers Read With Intelligence, Desire and Energy) , STAR (a computer reading program) and Homework Club.

During the 2008-2009 school year, student learning and achievement will continue to be monitored by all of our stakeholders. Parents are crucial to the success of the student population. Activities are arranged to encourage parents to take an active role in their child's education. These include, but are not limited to; Family Reading Night, Book Fairs, Parent/Teacher Conferences, PTCO (Parent-Teacher-Child Organization), Back-to-School Night, Open House and Parent Informational Nights.
